# National Access Forum Update – January 2017

# Summary of main topics - National Access Forum meeting 25th January 2017

# New Convenor -

The meeting was the first to be chaired by David Henderson Howat as the new Forum Convenor.

# Enduro cycling –

A paper from Forestry Commission Scotland and Scottish Land and Estates set out a number of issues for discussion around the increase in mountain biking, communications about Enduro mountain biking events, construction of structures and trails, and related issues of land management. This topic will be discussed further, with an initial site study visit to be arranged, and at the next Forum meeting to see if a working sub-group might be a useful approach.

# Mapping Core Paths -

There was an update at the meeting from staff of the Improvement Service on the shared mapping of local government spatial data in the 'Spatial Hub', bringing together and publishing a number of geographic data-sets <u>http://www.spatialhub.scot</u> which includes core paths mapping. There has been good progress lately, with only two authority's core paths data still to be loaded. The demonstration showed how the mapping will appear once available, and looked at some technical issues being dealt with.

There was a brief report on the meeting in early December of the Forum's sub-group on core paths and OS mapping, which had looked at developments and actions in this area. The spatial hub mapping when complete could assist with this process, and the working group is to meet again in coming weeks.

# Snowsport Touring Code of Conduct

Mountaineering Scotland reported that the draft code they have been preparing about snowsports touring activity in and near managed ski areas has now been issued, after discussions and finalisation with the Association of Ski Operators. #### Update on Your Park camping management in LLTNP -

The national park provided an update on arrangements for the byelaws which are due to come into effect on 1<sup>st</sup> March, with a presentation on the current work including the camping development strategy, provision planning, development of the Loch Chon site, signage, permit and booking systems, awareness programmes, staff recruitment and training, support systems and the monitoring programme. There was good opportunity for discussion, and the Park encouraged direct contacts with their communications team.

#### SRDP Improving Public Access grants scheme -

A brief update on the IPA grants scheme reported that the 2016 application round had seen the approval of some 41 applications from all parts of Scotland, with a value of over £1.8m, and contracts will be issued in the near future for those projects.
