# National Access Forum Update – May 2017

# Summary of main topics - National Access Forum meeting 17<sup>th</sup> May 2017

### Mountain Biking -

There had been a useful site study visit in March to look at issues at Glentress and Innerleithan mountain biking centres. The Forum meeting agreed to establish a sub-group to look into issues and approaches in greater depth, including lessons from other sports such as skiing, the role of online and other communication channels, and what guidance and advice can best assist in developing partnership approaches and good practice.

# Mapping Core Paths on OS -

The Forum's sub-group on Core paths and OS mapping met again in February. The Improvement Service mapping has now successfully completed the task of loading all 34 core paths plans onto the Spatial Hub mapping, as one co-ordinated data-set. Ramblers Scotland reported receiving over 1300 responses on their website campaign, overwhelmingly in favour of seeing core paths on OS maps. The sub-group's members are contacting some authorities in England to compare experience there, and have run a trial mapping assessment using South Lanarkshire as an example, to be taken further at the sub-group's next meeting arranged for early June.

### Scottish Land Commission -

The chair of the recently-established Scottish Land Commission, Andrew Thin, attended the Forum meeting to describe how the SLC was set up under the Land Reform (Scotland) Act 2016, as a non-departmental public body at arms-length from government, and is now working to produce a Strategic Plan of its priorities and approaches, for presentation to Ministers in September 2017. There was a wide-ranging discussion on topics such as possible ideas on land ownership and taxation, relationships with other national strategies, and with the Minsters' 'rights and responsibilities statement' stemming from the same Act. The SLC strategic plan is not expected to feature much on access issues, but it is useful to establish contacts at this early stage.

#### Occupiers Liability – Update on case law judgements –

This paper was welcomed in providing an update on some of the key court cases in Britain over the past decade relating to land occupiers' liabilities, providing further case law on topics including fencing, signage, real experience on risk assessment and inspections, and important recent judgements on injuries sustained by path users. It appears that the case may now move on to a further appeal at the Court of Session.

#### Revised 'Guidance for Local Authorities' document and consultation -

The draft of the revised and updated version of this government guidance has now been prepared, and will shortly be published for a 12-week consultation period, which will be widely notified.

# Forestry and Land Management (Scotland) Bill (as introduced) -

The Convenor noted that Ministers have now published draft legislation for forestry functions in Scotland, and for the management of forestry land and other land.
